## **CHAIRMAN'S REPORT**

# 15.96 Chairman's Report

## 8<sup>th</sup> September

A Parish Council meeting was held on this date by which time a leaflet flyer had been distributed throughout the parish, encouraging everyone in the parish to comment on the draft Neighbourhood Plan.

# 15<sup>th</sup> September

Councillors John Bull and Barry Dean attended a Parish Conference run by EHDC. One of the subjects covered was the problem of litter and waste and as a result of contacts made at the meeting, rubbish in the Cottered A507 layby has been cleared and a warning sign installed at the vulnerable site. These Councillors are also encouraging HCC Highways to rectify defects to the Peascroft road and the associated drains.

## 30th October

Completion of the road works on the B1037 has finally resulted in the replacement of the kerbstones on the corner of Warren Lane and also the unblocking of the drains around the junction. In nearby Church Lane the grass bank and road surface has been damaged as a result of the turning back of heavy vehicles. This has been reported to HCC Highways.

There has been a replacement for the broken seat at the top of Potato Lane.

#### 15.103 Buntingford Community Area Neighbourhood Plan (BCANP)

The consultation period for the Buntingford Community Area Neighbourhood Plan has now ended. The next stages of the process will be submission of the Final Plan and supporting documents to East Herts District Council followed by a further 6 week consultation by East Herts District Council. There will then be an Independent Review of the Neighbourhood Plan by an Examiner and a Referendum within which the community will be asked to vote if it is agreed the Plan meets the Neighbourhood Plan Regulations.

# 15.104 Telephone Box

The Clerk is in the process of obtaining quotes for the cost of painting and general repairs to the telephone box with a view to getting the work done in the spring when the weather will be more conducive to the work required.

# 15.106 Overgrown hedges affecting The Crescent Cottered

The Clerk has contacted Circle Anglia Housing on two occasions to report problems with overgrown hedges. This has now been resolved regarding some properties but an issue remains with 4 The Crescent where growth to the hedge at the front of the property is still obscuring a clear view for drivers when turning onto the A507 Baldock Road from The Crescent and Peascroft. The Clerk has now reported this to the Circle Anglia Neighbourhood Officer and is awaiting a response.

# 15.107 Winter Self Help

The Clerk has requested a delivery of the Winter Self Help salt from HCC. Councillor David Charles offered to take delivery and distribute as required.

## 15.108 Annual Playground Inspection Report

The Clerk provided two quotes from individuals who specialise in the repair or refurbishment of playgrounds. Councillors considered the quotes which were thought expensive. The Clerk is tasked with contacting Wicksteed Playgrounds to investigate the price of replacement parts.

# 15.109 Gang Mower

It was reported that the gang mower used to cut the Recreation Ground was in need of sharpening. The Clerk is tasked with obtaining quotes from two local companies who carry out such work and usually offer a reduced rate in the winter period.
